II. Learning Management / Licensure Integration

- Preview of integration and Learning Management Platform
 - REMSA is rolling out a cloud-based system level learning management platform that will integrate licensure, renewals, education and etc. all in one
 - Free for our providers to use
 - Currently Corona Fire is testing out the platform before its release
 - o Dustin Rascon gave a quick tour of the platform Brainier on how it works and looks
 - REMSA will be using this platform starting July 2023 to deliver PUC packages and providers can also use this to create their own education
 - After logging in, each user will go through an accreditation and licensure model that will then create their type of profile
 - In 2023 looking to also integrate ImageTrend into Brainier for a single sign-on

III. Identified Issues and System Updates

- Zoll importing issue on Zoll's side
 - Zoll may be having server issues that is causing the importing issues, REMSA may need to reconnect with
 Zoll to discuss the problem
- Incorrect Zoll serial number when transferring waveform files to another agency (pending)
 - Will hopefully be corrected by the next update
- CATT Team Documentation
 - o In the Hemet/San Jacinto EMS area, a new pilot program launched that is called CATT (Community Assessment and Transport Team), in collaboration with RUHS-Behavioral Health, where if EMS providers responds to a patient who is only having a behavioral health crisis, can contact AMR to dispatch CATT if available. A clinical/mental health therapist will respond and take over patient care
 - REMSA recommended EMS providers to use this program and to make sure documentation is done properly for using the CATT team in it.dispositon041

• Cal Fire asked for further clarification in reference to assess and refer regarding documentation for this type of call. Nick will set up a separate meeting with them to discuss further

- eVitals Validation Rules

 - o Providers are going down patient contact route, and transitioning to assist other agency, what is the appropriate way to enter this type of transition in the ePCR
 - o Nick will have further discussion with Justin Vondriska and Rick Harvey on this
- Validation rules regarding Narcan Admin/Narcan Kits
 - REMSA proposed to make this a mandatory field to complete in the opiates panel
 - o ePCR workgroup agreed to tying a validation rule to it, so it is required to be answered
- Attachment Validation
 - o Included in the last upgrade
 - o Require attachments to be included in the call if you have a facesheet etc.

- Igel documentation reminder, REMSA will be doing 100% CQI on these
 - Also documentation complications for ET
 - Cal Fire noted* when igel is subjected to extreme heat, that the green area of igel at the bottom and fluid within that changes the dynamic of the tube and breaks away when inserting
