#### II. Identified Issues and System Updates

- 22.10.1 Upgraded past Tuesday
  - NEMSIS 3.5 field upgrades
  - Can now set preferred lists (more customization) in powertools
  - More functionality with tied fields and auto narratives
  - NIFRS will now aggregate
- System stability x2 the past month lasting about 30-60 minutes
  - If any provider sees any problems with the CQI module, please let Nick know. Sometimes the errors are related to the stability bug problems

#### **III. Change Requests**

- eVitals Validation Rules Discussion and Examples
  - $\circ$   $\;$  We can provide agency level validation rules when needed
  - o 11 new (0 point) validation rules were written
  - o Nick reviewed and showed examples of the before and after change of these rules
  - Asked the group if they were willing to institute these types of rules to their agencies as well
    - Epcr responded in support of these changes
    - Rules will start tonight at midnight as a whole system change
- Any agency looking for attachment validation?
  - Proposed another (0 point) validation change
  - o At the last update, we can now add validation rules to attachments
  - o Looking towards a softer roll out of this to include advance directives
    - Epcr responded in support of this proposal

- Outlook for NEMSIS 3.5 for 2023
  - Mark Roberts is no with ICEMA
  - CA is now on the NEMSIS 3.5 roadmap as a state to possibly participate in state implemented changes
  - Nick would like the groups input to come up with a plan to prepare for that possibility before the state implements anything
- Health Information Hub
  - Coachella Valley is pursuing a health information hub with elite database
  - o Expectation of medical record and encounter number to be linked
  - This configuration will provide us with 100% outcome data
  - Nick will look into working with QR codes for this, or UUID (Universal Unique Identification), the idea is that NEMSIS 3.5 in the background will automatically unify the records through UUID
- Brainer/LMS Update
  - Integration building has begun
  - Looking at a release date by quarter 1, 2023 for providers to start using
- Legacy data reminder (Vault)
  - A system called Vault, version 2 NEMSIS, Sansio data repository archives our old data (pre-2017)
  - Nick reminded agencies that have not done so yet to get a login, to reach out to him to attain one to access their old records
- Pilot program of ImageTrend Continuum
  - Continuum product available to users for use of dashboards and monitors, cqi etc.
  - o Nick will make it available to agency admins and super admins
  - When you are in Elite, you can click on tools, then the button that says continuum
