## I. Call to Order/Introductions

- Any action items presented here, REMSA will accept as approval of the group who attend the meeting
- Meetings will be held via Microsoft TEAMS for the foreseeable future. All meetings will also be recorded.
- New administrative policy #8208 is live, changed the name of the ePCR workgroup to the Data Standards Committee
- Introduced Michael Moore, who will be assisting Nick in his role as the elite administrator and affiliated programs

## II. NEMSIS 3.5

- NEMSIS 3.5
  - Migrating in 5 months, October 2023
  - Working on a library and template to provide a smooth transition over for everyone
  - Will include agency level validation
- Validation Rule rewrite with error messages
  - Work in progress on bringing explanations/context into the error messages that will direct field providers to different portions of the pcr to ensure their data is coinciding correctly and aligned
  - Will spend special attention to the CARES panel
- Finishing Disposition matrix 3.4 to 3.5 mappings

## III. Identified Issues and System Updates

- Narcotic Signature transfer
  - Will be fixed by June 5<sup>th</sup>, 2023
  - With 23.5, will put an extra section in the transfer filters
  - IT control substance filter, will put it as a system level default
    - Can have it selected only for your own agency etc., configuration
- CARES Export for 3.5 resolved
  - Continue sending info into the CARES registry 23.3, 23.2 all CARES mapping completed and resolved
- Additional Identifiers
  - Identifying grid of the patient, for second patient in the transport with same/similar names

- Audit Trail multiple entries
  - Fixing problem with auto locking that occurred in nov/dec last year
- Bar code scanner fix (ID scanning)
  - In regards to taking pictures to attach into the pcr, or scanning drivers license
    - 23.4 upgrade fixed the photo scanner, so it captures and scans it more easily instead of trying to focus
    - Fixed with windows and apple products
- Apple device users
  - If you are using IOS 16.4 and 16.4.1 security settings blocking cookies will block the website and not allow functionality
  - Received an email from ImageTrend that so far they do not have a resolution for this, only solution so far is to not upgrade to the newest IOS yet until apple fixes it
  - Not only a problem with ImageTrend but affects all since the error is on apple side

## New requested Items

### IV. Change Requests

- Any PUC Training questions related to the ePCR or data collection methods
  - Kristie, Cal fire asked regarding clarification on BGL <60 or <80, the CORE Measures and our current protocol does not match
    - Would be beneficial to have something in the action panels stating what is needed to help capture these calls better
  - Melissa, Hemet Fire asked regarding patient phone number for minors, is there any way to have it auto populate on the second part so they don't have to go back to fill it in
  - Melissa, Hemet Fire asked if we could add pick up facility - assisted living as an option under incident location
    - Currently we cannot since the State list does not have it
    - Can look into putting it as skilled nursing facility / assisted care, or maybe under private commercial establishment
  - Joe Silk, Cal Fire requested clarification on transfer from BLS provider to ALS provider within the same agency issue

### V. Best Practices

- Situation and Power tools presentation by Corona Fire and AMR for concurrent documentation best practices
  - Went over displaying options, calculation charts, format driven protocols, availability upon request, building the protocol itself, making it more efficient in capturing data, form manager, generic label and building new grids

- Erin Bailey asked regarding the status of Data Mart
- Brainier and licensure is done, ready to launch with everyone who wants to use it
  - If you are interested, contact Dustin for a demo and setup
- Sean Hakam discussed medication roll out for opioid withdrawals called buprenorphine

- A protocol will accompany this medication roll out
- A scoring system if patient meets criteria and threshold to indicate treatment with buprenorphine
- Education will be put on Brainier along with the protocol change next year PUC cycle
- Rick Harvey asked regarding site to site transfers with AMR Rancho
  - Can be possible, but need to discuss this with ICEMA first
  - Local site to site transfers with other agencies
